*"2010 Olympics: Behind the Scenes"*

In May 2006, Dan Doyle joined VANOC as its executive vice president, construction with responsibility for the \$580 million development and building of the 2010 Olympic and Paralympic Games venues.

Large complex building projects are second nature to Doyle. With more than 35 years of experience with BC's Ministry of Transportation, most recently as deputy minister, he has overseen some of the province's landmark construction initiatives. Highlights include the rehabilitation of Vancouver's Lions Gate Bridge and the development of the Sea-to-Sky Highway Improvement project. Doyle also served as chairman for Rapid Transit 2000, the company responsible for building the Millennium Line extension to Vancouver's rapid transit system.

Dan Doyle was appointed Chair of BC Hydro's Board of Directors on July 16, 2009. A civil engineer by training, Doyle's lengthy career has been recognized with many accolades, including the Canadian Transportation Person of the Year (2005) and the Lifetime Achievement Award from the Institute of Transportation Engineers. In addition, he was awarded the Lieutenant Governor's Silver Medal for Excellence in Public Administration (2002).

## Last Month Speaker



**Dr. Brett Skinner thanked by David Osoba**

Dr. Brett Skinner, President and Director, Health Policy and Insurance Policy Research of the Fraser Institute gave us his inaugural speech since moving to Vancouver from Toronto. He gave an excellent talk about Health Care in Canada with ample comparisons to other provinces and countries. His presentation included many statistics and tables; this probably made all the retired accountants in the audience happy.

From his viewpoint health care is about patients and taxpayers. Among the 30 major countries Canada ranks 7<sup>th</sup> in the amount spent in relation to its GDP with 10% going to health care. The USA is 1<sup>st</sup> at 15% of GDP.

He pointed out that health care spending is growing faster than inflation and faster than government revenues. The amount spent on health care is taking up more and more of government expenditure and is now around 50%. This rate of growth is unsustainable unless we change our approach. Meanwhile, Canada ranks low in the number of CT scanners and MRI machines: Canada has 12 and 6.2 compared to USA with 34 and 25, and Japan is first with 91 and 40.

In the area of pharmaceuticals, Canada does have control over brand name drugs which are 50% lower than in the USA but our generic prices are twice that of the USA. In addition, it takes much longer to get approval for new drugs in Canada compared to the USA and Europe.

Dr. Skinner felt that the answer to our out of control costs is user fees and paying hospitals for service on a use basis rather than block funding. Since most taxpayers are isolated from taxes on health costs, there is very little political will to bring in significant changes that may upset the voters.

## President's Notes

It's good to be back! I was very interested in Dr. Brett Skinner's presentation on what's "broken" in the Canadian health care system. The cost of health care is outpacing both the GDP and the amount of income that governments can generate from taxation. It's of interest that three of the "fixes" he proposed are in the news now. Quebec and Ontario have added "health premium" taxes and Quebec wants to charge a user fee for each doctor visit. Ontario is bent on reducing the price of generic drugs by preventing the manufacturers from giving pharmacies rebates to sell them. This seems reasonable – although the overall savings to the cost of health care will be in the vicinity of only 1%. And BC announced that it will pilot a proposal to pay hospitals based on the number of patients they treat and the services they provide. This is in contrast to the block funding the province now provides to hospitals irrespective of the work actually done.

Most European countries pay hospitals based on service which seems a reasonable way to do business. Another way has been proposed in a report entitled "*Bending the Health Care Cost Curve*" authored by a trio of Ontario organizations. This report advocates paying for health care based on treatment outcomes - that is, is the treatment successful, and not just on the number of treatment visits. Will these proposals actually save money? No one is certain that they will. And even more important - will they improve health care outcomes? That's the big question.

The above mentioned initiatives by governments are about economics, not health outcomes. Longevity (the number of years lived) and healthy life years (the number of years spent in good health) are probably determined more by public health measures like sanitation, a clean water supply, proper sewage disposal, mass immunization to prevent communicable disease like measles and polio, as well as good diet, avoidance of smoking and lots and lots of exercise. So keep on golfing, go to the gym or go walking, and watch out for the worst sign of a good life - that big roll around the belly!

## Parking at Capilano Golf and Country Club

We value our ability to meet at the Capilano GCC premises for our monthly meetings.

Capilano GCC has brought to our attention that most of us have been parking in areas intended for “Club members only” as well as in the “Handicap” slots. These areas are known as the “upper” lots. They are heavily used by Golf Club members during the spring, summer and fall.

From now until November 1<sup>st</sup> we are to use only the “lower” lots, unless you have a Handicap sign and/or are a Capilano GCC member. The lower lots are located to the left after we enter the grounds. There will be a parking attendant stationed on the main road who will guide us. There will be 2 jitneys at the lower lots to give a ride to those of us who wish to use them. Others will walk the road or use the stairs to the front of the clubhouse. Please note that the jitneys will not be available after the meeting.

After November 1<sup>st</sup> and till March 31<sup>st</sup> we will be permitted to park in the upper lots as there will be many fewer golfers and other members using these lots during that period.
