**Pierre Gratton,**

President and CEO, Mining Association of British Columbia  
*“Mining Industry in BC - Current and Future”*

Pierre Gratton is President and CEO of the Mining Association of British Columbia (MABC). The MABC is the predominant voice of mining in British Columbia representing mineral producers, coal producers and companies involved in exploration, development and smelting of minerals within the province. MABC promotes the interests of its members provincially and nationally, and works with governments and other stakeholders on policies affecting mining, to inform the public, and to promote cooperation between member firms to solve common problems.

From 1999 to 2008, Mr. Gratton served as Vice President, Sustainable Development and Public Affairs for The Mining Association of Canada (MAC). Previously, he served as Director of Communications for the federal Minister of Natural Resources and Minister of Justice and Attorney General.

In 2005/2006, Mr. Gratton was honoured as a Distinguished Lecturer for the Canadian Institute of Mining, Metallurgy and Petroleum (CIM).

Mr. Gratton holds an M.A. degree in political science and a B.A. from McGill University.

## Last Month Speaker



**Dan Potts and Rick Antonson**

Rick Antonson, President and CEO of Tourism Vancouver, provided an informative and entertaining presentation. Along with providing numerous facts supporting the importance of tourism to Vancouver and British Columbia, Rick presented two inspirational videos commemorating the success of the 2010 Winter Olympic Games. It was great fun to relive the exciting moments of this historic event, revel with the screaming fans at the hockey games, and to view again the elegant opening and closing ceremonies.

Rick was introduced by Ed Strom, a member of our club who has served as a volunteer with Tourism Vancouver for over ten years. Ed is one of more than 250 very essential volunteers that work with Tourism Vancouver to provide hospitality, information and assistance to Vancouver visitors.

With over 1,000 members and 60 staff Tourism Vancouver works to promote the tourism industry in Vancouver which annually serves over 8 million visitors who spend \$3.5 – \$4 billion per year.

Rick acknowledged that Vancouver's success is only possible because of the great attractions of outdoor BC. Tourists come to ski, snowboard, hike, canoe and visit the many natural attractions. As part of their trip they will spend a few days in Vancouver.

The new convention center is also contributing to the growth in visitors to Vancouver. Prior to the center, the annual average number of convention visitors was 90,000. This year it is expected that the number attending conventions will reach 220,000.

Tourism is always dependent on international developments. Currency values and international political issues will impact tourism. With the achievement of approved destination status in China, for example, visits from that

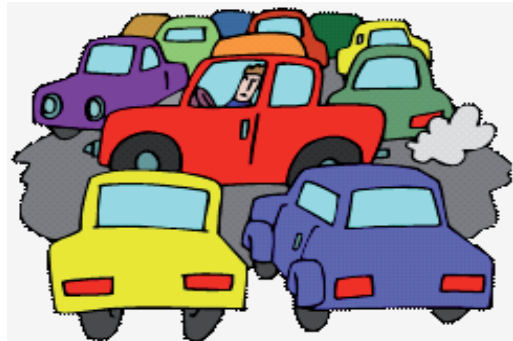
country are expected to increase by 22 percent.

In the question and answer period Antonson expressed support for retaining the HST as is. He noted that the restaurant business in Vancouver is up 4% since the introduction of the HST and “It would be a calamity to try and unwind it now.”

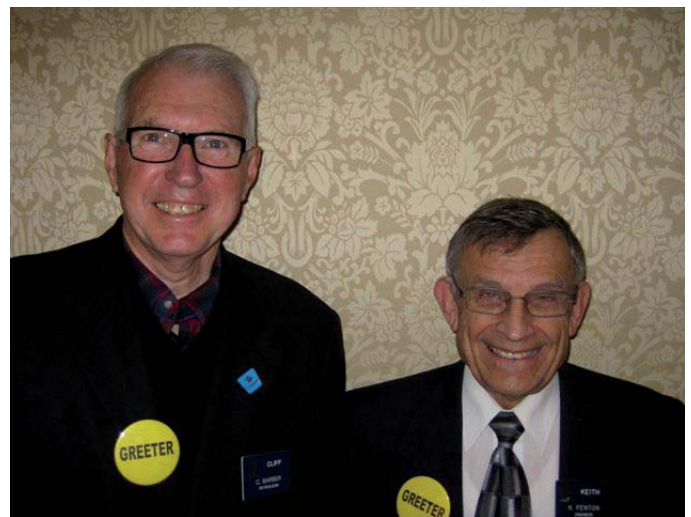

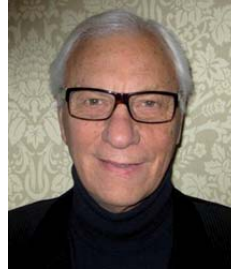

## Brief Backgrounds of a Few of Our Recent New Members



**Russ Fraser** (*member since October 2010*) was born in Vancouver and lives in West Vancouver. After graduating from UBC with a BA. Sc. he had a varied business career with companies large and small, culminating with the presidency of Terra Engineering Laboratories. Russ was active in the volunteer sector, mainly with CNIB and the Engineering Association. He became active in public life in the 70's becoming Chairman of Vancouver Parks Board and entered BC politics in the 80's serving in several Ministerial posts, including Post Secondary Education, Solicitor General and Attorney General.



**Barry Heselgrave** (*member since December 2010*) was born in Brandon, MB and lives in West Vancouver. After graduating from Brandon College with a B. Maarten came to Canada in 1959 to study microbiology at McGill University in Montreal where he later co-owned and managed a clinical microbiology laboratory for over 20 years before moving to Vancouver in 1986 to join an international microbiology company.
