Dr. André Gerolymatos,

Chair of Hellenic Studies at SFU

"The Way Forward in the Middle East"

Dr. Gerolymatos is one of the most dynamic and interesting speakers we have had address our Club and we are delighted to welcome him back for an unprecedented seventh time. As such, he hardly needs any introduction.

Prior to joining Simon Fraser University, Dr. Gerolymatos was Director of the Hellenic Studies Centre at Dawson College in Montreal. In addition to the numerous books and articles, he has written on conflicts in the Mediterranean and Middle East, and he has lectured on those subjects at Harvard and Stanford Universities.

He is an internationally recognized authority on Middle East affairs, specializing in military and diplomatic history and has published articles and books on these subjects. The great value in his presentations is his ability to provide clear and concise analyses of the current problems in the "hot spots" of the region and its constantly changing dynamics.

In addition to bringing us up to date on what has happened during the past year, Dr. Gerolymatos will deal with possible solutions to the Middle East problems.

Dr. John MacDonald is Chairman and CEO of Day4 Energy Inc. A record 195 attended his presentation about Energy in the 21st Century; a time when demand is expected to exceed the availability of conventional supplies. John also talked about evidence of climate change, the big driver behind the move to use renewable energy.

The outstanding quality of life enjoyed over the last 100 has been enabled by an ample supply of low cost energy and that is about to change. Three issues are bringing this change; security, global warming, and balance in the supply and demand of energy.

A German think-tank and The Royal Dutch Shell Group, predict that solar energy will supply 65% of energy world wide by 2100. All US energy requirements could be provided by using 150 sq km of solar panels in the Arizona desert, while 250 square km of the Algerian desert could power the entire planet. Renewable sources are secure (local), environmentally friendly and inexhaustible but, they are also intermittent and location dependant. Large scale energy storage is required to provide power when needed. Implementing a power system based on renewable sources will require new technology in the power grid; something that is now being talked about as the “Smart Grid.”

John also talked about climate change. Carbon dioxide in our atmosphere has climbed to 387 parts per million. There is disagreement over the role played by human activity, but scientific models now show that existing levels lie within reasonable bounds that are modeled based on actual fossil fuel consumption levels. Eleven of the 12 years from 1995 to 2006 were the warmest measured since 1850 when measurements began. Rapid change in climate has caused problems. Four of the last 5 great extinctions on earth are thought to be the result of rapid climate change.

The northern ice cap has shrunk dramatically since 1982. The river flows that depend on glacier melt during summer months are drying in some cases. This alone may bring serious problems in parts of the world.

A renewable energy supply is one means that is available now to reduce our dependence on fossil fuels. BC is fortunate in having ample supplies of almost all forms of renewable energy.


Brief Backgrounds of a Few of Our Recent New Members
