Dr. Warren Jestin,Chief Economist, Scotiabank "From Recession to Recovery"

Last Month Speaker

Strongly agree? Somewhat agree? Strongly disagree? Somewhat disagree? Just like a marketing survey. Those are the choices we were left with following Dr. Grubel's presentation. Certainly, neutrality was not an alternative.

Economics was the thrust of Dr. Grubel's thought provoking subject, "Mass Immigration and Canadian Living Standards". In support of his position that immigrants are a cost to "born in Canada citizens" he presented some quite shocking numbers.

His data indicated that an immigrant, on average, pays about 50% less tax than Canadian-born citizens pay. This amount of tax is less than the estimated cost of services that immigrants receive. Although many of those "costs" were based on assumptions, he, nevertheless, calculates that the annual "financial transfer" to immigrants from existing Canadians is about \$8,900 per immigrant. On that basis, he calculates that between 1986 and 2005 when Canada received approximately 4.2 million immigrants, the "financial transfer" amounted to almost \$38 billion or about \$1.9 billion per year. That, he contended, was the ongoing cost to existing Canadians of the current immigration policy.

Audience participation was encouraged and many thoughtful questions and some challenging statements put forward. A "hands up" poll of members prior to his presentation, regarding whether their preference was for (i) more immigration, (ii) maintaining the status quo, or (iii) less immigration, indicated a majority in favour of one of the first two choices. Afterwards, there appeared to be only a little movement to the latter preference of less immigration.

Obviously immigration is and will remain controversial and we were most fortunate to have Dr. Grubel address us and challenge us to again consider the merits and faults of the government policies and our attitudes toward this important subject.
