Ian received his Bachelor of Commerce from the University of British Columbia and is a member of the Institute of Chartered Accountants of British Columbia. Prior to public service he served seven years as a chartered accountant in public practice.

## Last Month Speaker



### President Dan Potts thanks speakers Jeff Bowser (L) and Martin Eady (R)

Jeff Bowser, Investigator, Enforcement Division and Martin Eady, Director, Corporate Finance, with the BC Securities Commission (“BCSC”) spoke about “*How to Protect Yourself from Securities Fraud and Inappropriate Investments*”.

The real life examples presented by Jeff Bowser really put a human face on securities fraud. Fran, a recently widowed mother with two children had a good friend, Bob, who had promised Fran’s husband to look after her. Fran received \$25,000 as a result of her husband’s death and was interested in earning more than 1-2% on bank deposits. Bob told Fran of his friend John who was earning 12-25% on two year term investments with a fellow named Stephen Hugh. John promoted the investment with Fran seemingly with a “personal guarantee” that Fran would not lose her money and Fran invested her \$25,000 with Stephen. Two months later Stephen calls a meeting and explains to his investors the money is all gone and he blames the events of 9/11. John, unfortunately, has no recollection of providing a “personal guarantee” to Fran.

Fran is left without her \$25,000 savings with two dependent daughters. The stress impacts her health and her relationship with family and friends as she is ashamed of her stupidity and unwilling to discuss the tragic events.

Another example from BCSC files involves a retired RCMP officer. He was solicited to make an investment that he suspected was shady but thought he would try it out, since the investment was only \$5,000. Three weeks later he received a check for \$7,000 and it cleared the bank. Then it was \$20,000 that quickly turned into \$30,000. Six months later he agreed to mortgage his house and invest \$150,000. At that point the investment promoter skips

town and is gone.

As a result of such frequent occurrences of fraud, the BCSC has embarked on a communication campaign to inform the public to beware of securities fraud. For more information visit “*InvestRight*” at [www.investright.org](http://www.investright.org).

The most important thing for investors to remember is the “*Red Flag Warnings.*”

- Promises of Guaranteed High Returns
- Off Shore Investments with Ownership and Legal Jurisdiction Issues
- Told it is a Great Opportunity! (Why you?)
- Secrecy Requested – Don’t Tell Anyone!
- Get in Now or You’ll Miss a Great Opportunity

No legitimate business or individual would offer such guaranteed high returns. If they could offer such a guarantee, they could borrow at the bank for a much lower rate.

The BCSC is a self funded agency with 200 employees. Companies using BCSC services raised \$15 billion last year for investment in new ventures.
