**Danny Catt, B.Sc., M.Sc.**

Renewable Resources Technology, BCIT, Ecologist, and Photographer  
*"Canada's Arctic - A Photographic Journey"*

Danny is a wildlife ecologist, world traveller and internationally published photographer. For the past 25 years, he has explored and photographed the people, landscape and wildlife of over 60 countries around the globe. Wherever he travels, Danny's photographs capture the beauty and awe of the natural world and its creatures – from the curiosity of seals in Antarctica to the majesty of Polar Bears in the Arctic. His photographs have been published in Canada and internationally – in the Globe & Mail, New York Daily News, Chinese Geographic, TIME Magazine and others. Danny's photographic journey through Canada's Arctic will include commentary about its current issues, people, history, and features, and his own experiences there.

A graduate of SFU, Danny has taught ecology and conservation in BCIT's highly regarded Fish, Wildlife & Recreation program since 1996. Previously he worked for 13 years with Parks Canada in environmental education and park planning. When not teaching, Danny works as a trip leader, photographer and naturalist for adventure travel companies around the world.

As a Rotary Foundation Scholar in the early 1990s, Danny studied at the College of African Wildlife Management in Tanzania, on the slopes of Mount Kilimanjaro. He is a Fellow of the Royal Canadian Geographical Society (2012), and a Member of the prestigious New York City based Explorer's Club (2011). For two consecutive years (2009, 2010) he received Rotary International's Service to Humanity Award. In 2008 the City of Burnaby, where Danny lives and teaches, honoured him with its Environment Award.

## Special Events - UBC Wine Research Centre Tour

### UBC Wine Research Centre Tour of Tuesday, March 4

In spite of the rain, it took no arm twisting for a large group of members to tour the UBC wine research facilities. It is headed by Dr. Hennie van Vuuren, an affable and highly knowledgeable professor from South Africa. He enjoys his work! We first listened to a lecture on some of the research they are doing. Through genetic engineering the centre has developed a red wine yeast that will not give people headaches. Unfortunately the large producers won't touch it because of possible (US?) lawsuits, and smaller wineries which do use it won't say which wines are made with the yeast.

After the lecture we had a tour of their world class labs, and then the "wine library". To our delight there were no books but 8,000 bottles of wine, with one valued at \$26,000. This and many others are acquired by private donations, or from wineries.

Finally we had a delicious cold plate lunch and tasted four of his favourite wines, which he described. They are:

1. Quail's Gate Dry Reisling (BC Liquor)
2. Springfield Life from Stone (Liberty Wines)
3. De Toren Fusion Five (BC Liquor)
4. Penfold's Shiraz BM28 (BC Liquor)

## Last Month Speaker - Dr. Robert Evans

### Dr. Robert Evans - Health Care in BC

“Health is merely a state of inadequate diagnosis.”

Bob Evans has been professor of health economics at UBC for many years, and is well known by the medical professional. He has now lost his eyesight, and has retired.

The title of his talk was “Who pays, who gets and who gets paid.” Well, we know the answer but not all the details. He began by stating that there is a lot of misinformation about health care put out by the media. They either don’t do their homework, or simply don’t understand. For example, we are always told that health care costs continue to rise, but relative to GDP, they have dropped for the last four years. We are also told that seniors are the main cause for that increase, but in fact seniors contribute about 1% to any cost increases. Physicians’ services are increasing at only 0.4 to 0.5% a year and long term care costs are increasing at about 2% a year. Drug costs are pushing up the health care costs, as are more frequent and costly lab tests.

We are also told that there is a doctor shortage. This over simplifies the problem. There is a doctor shortage in small towns and in the North, and there can be temporary shortages elsewhere. There are many new grads coming from our medical schools, there are Canadian grads trained out of Canada who want to return, and there are many foreign doctors who would like to practice here. The shortage is not in supply but in licensing. There will soon be an over supply of doctors in BC.

It is fairly simple economics to predict the future health care costs. Demographic trends are predictable, and those can be matched with the age-use curve (how people historically need medical services from birth to death). The result is about 1% cost increase per year. So increasing health care costs are attributable to these other factors.

Referring to his opening remarks (well, some of them), the healthy and wealthy tend to pay more for services they don’t use, and the poor and sick pay less in taxes and often

need greater health care. Compare the healthy professionals in West Vancouver to the drug addicts in the Downtown East Side. The latter pay little or no taxes, but need more care.

Many questions followed and were answered with varying degrees of enthusiasm.

On Friday, March 21, I had a further conversation with Bob Evans to try to answer some questions.

1. What do seniors cost the health care system? There is no readily available answer, but it is significant.
2. What are some of the other major costs? Prescription drugs add about 15%, long term care about 10% (this is very approximate), and acute hospital care is very close to 30%. This includes lab work, MRI’s etc.
3. Total cost? Nationally, it was \$211 billion in 2013, and in BC, \$17 billion.
4. Are there other countries who have a better system? Not particularly. Each good health care system has its strengths and weaknesses; each must be tailored to that country, and Canada’s is one of the best.
5. When asked which is the best system, on reflection Evans said the best is the American Veterans Health Administration. This came as a surprise. It is separate from Medicare and Medicaid. There are three reasons: the VHA has excellent doctors, and is tied to the medical schools. It has a high degree of computerization and automation, and was doctor designed. Evans said there is an excellent book on this titled *Best Care Anywhere*, by Phillip Longman, (\$12 through Amazon)
