Dr. William Rees

Professor Emeritus, Ecological Economist

“The Human Eco Footprint: Marching Toward the Abyss?”

Dr. William Rees is a human ecologist, ecological economist, Professor Emeritus and former Director of the University of British Columbia’s School of Community and Regional Planning, where his research and teaching focused on the biophysical prerequisites for sustainability in an era of accelerating ecological change.

Prof Rees is perhaps best known in ecological economics as the originator and co-developer of ‘*ecological footprint analysis*.’ His book on eco-footprinting, with then PhD student Dr Mathis Wackernagel, has been translated into eight languages including Chinese. Widely adopted for sustainability assessments by Governments, NGOs and academics, the human ‘eco-footprint’ has arguably become the world’s best-known sustainability indicator. Prof Rees’ most recent writing focuses on neuro-biological, cognitive and cultural barriers to sustainability, including human’s well-developed capacity for self-delusion. He has authored (or co-authored) more than 150 peer reviewed papers and book chapters, and numerous popular articles on humanity’s (un)sustainability conundrum.

Active across disciplines, Dr Rees is a long-term member of the Global Ecological Integrity Group, a Fellow of the Post-Carbon Institute, a founding member and past President of the Canadian Society for Ecological Economics and founding Director of the OneEarth Initiative. He has lectured by invitation throughout North America and 25 other countries around the world; the Vancouver Sun named Prof Rees one of British Columbia’s top public intellectuals in 2000; in 2006 he was elected to the Royal Society of Canada and in 2007 he was awarded a prestigious Trudeau Foundation Fellowship. Laval University in Québec recognized Prof Rees with an honorary doctorate in 2012, and he is the recipient of both the 2012 Boulding Prize in Ecological Economics and a 2012 Blue Planet Prize (jointly with Dr Wackernagel).

This topic ties in nicely to a book that I am presently reading called "Sapiens" by a chap called Harari. While we may not all agree with these views, it is really interesting to hear them as well as alternate views of life on our planet.

Last Month Speaker - John Barker, West Vancouver Streamkeepers

John Barker, president of West Vancouver Streamkeepers, gave an informative and delightful talk on the many activities and objectives of Streamkeepers. He also discussed its sister organizations, the Shoreline Preservation Society and the Estuary Enhancement Project.

West Van has twenty two streams which have been used by salmon for spawning. As the community grew, culverts replaced open bridges, and long tunnels were put in, such as the one for Lawson Creek from Argyle to the Legion Hall. All this enhanced the roads, and usually prevented flooding, but it did nothing for the salmon. Eventually we woke up to what we had done.

As someone said, "If nothing lived in the streams, no one would care", but the streams are full of life. As well as the salmon, there are little cutthroat trout in virtually every pool, as well as a myriad of invertebrates, such as stone flies, caddis flies and scuds. It's a busy place if you get close enough.

Streamkeepers has a little hatchery on Nelson Creek just above the Upper Levels. Here, about 130,000 fry are raised each year, and distributed to the various creeks. This is done by some of the ninety dedicated volunteers. Streamkeepers has engaged the schools very successfully, with the students from elementary to university level helping in different ways.

Fixing our mistakes takes time and money. Land clearing, buildings and roads above the Upper Levels has led to fast runoffs and scouring of the creek beds, making the culverts even harder to swim through. Many culverts now have baffles of various designs. A number of creeks have fish ladders which help the salmon, but not entirely. The rearing ponds have been very successful. You can see them in Memorial Park and Hay Park. The logs and

stumps while unsightly, provide cover for the fry.

The most productive creek is Brothers, which joins the Capilano River just at the end of Clyde Avenue. It normally has about 1000 spawning Chum and Coho each year, plus a strong run of Pink salmon every other year. An excellent place to see them from mid October to mid December is at the viewing platform on Keith Road three blocks east of Taylor Way.

The sister organizations are also making a difference for migrating salmon. The Shoreline Preservation Society has the goal of enhancing the intertidal zone for the benefit of plants, fish, and other life found along a shore. You may have seen large boulders being placed at very low tide to break up tidal currents and stop erosion. Similarly, the Estuary Enhancement Project has done great work in improving the estuaries of Lawson and McDonald creeks. Instead of the water spilling over a sill, straight out of a culvert, it now winds through the rocks in a defined creek channel in a much more natural way. Rogers Creek is the next one slated for estuary improvement.

Don't forget to watch for the opening of the Nature House at the mouth of Lawson Creek and Argyle, and enjoy seeing the return of the salmon to West Vancouver.
